Tax Payment Deadlines...

Full payment: Taxes due on or before January 31, 2013 to the Village Clerk.

Two part payments: First installment due on or before January 31, 2012 to the Village Clerk and second payment due on or before July 31, 2013 to Marathon County Treasurer.

Payments received or post-marked on or before December 31, 2013 will be receipted in 2012, if the taxpayer is seeking an income tax deduction for calendar year-end 2012.

Lottery Credit: If you owned and occupied your home as your primary residence on January 1, 2012 your taxes should include the lottery credit. Please review your tax bill to ensure you are receiving this reduction in taxes. If this has been omitted, please contact the Village.

Mailed Receipts: If you request a receipt please include a self-addressed stamped envelope with your mail-in payment.

Overnight Parking

Rules are now in effect until April 1, 2013. No one can park on the streets overnight unless authorization by the Police Dept.

Sidewalks: All sidewalks within your parcel or lot shall be kept clear of snow and ice. The owner has 24 hours from the time the accumulated snow or ice has stopped to clean their sidewalks. Sprinkle with sand and/or salt to provide a safe travel environment for pedestrians. Failure to do so creates an immediate danger of public safety which will result in a written letter to owner. If further action is necessary, the expense the Village accrues to clear the walks will be assessed to the property owner.

Notice to Dog/Cat Owners...



Throw out the old, bring in the new. Not the cats and dogs just the tags. These annual licenses, which were issued during 2012 expire on December 31, 2012 and need to be renewed. After March 31, 2013, a \$5 late fee will be charged on top of the regular cost

for all license renewals. Your application, license fee and current rabies vaccination certificate are required to license your pet. Do not include payment with property taxes.

Village Caucus...


