Notice:

*Wis. Admin. Code PSC 185.38 requires utilities to offer deferred payment agreements (DPA's) to residential customers who are unable to pay their bill in full. A DPA consists of two elements: a reasonable down payment and an installment plan to pay the remaining outstanding balance over a specified period of time. **On a quarterly basis, a customer with a DPA is required to pay his or her current charges in full, in addition to the agreed upon installment payment.** The Village of Edgar must receive each payment on or before the due date. A late or missed payment will cause the DPA to "default" and place the customer in jeopardy of disconnection. Upon default, nothing herein shall constitute a waiver of the rights on the part of the Village of Edgar to collect the unpaid balance or to prevent it from exercising its right to disconnect service because of such delinquency. In the event service is disconnected, the utility may require a deposit under PSC 185.36 to insure payment of future bills.*

IF YOU ARE NOT SATISFIED WITH THIS AGREEMENT, DO NOT SIGN. IF YOU DO SIGN THIS AGREEMENT, YOU GIVE UP YOUR RIGHT TO DISPUTE THE AMOUNT DUE UNDER THE AGREEMENT EXCEPT FOR THE UTILITY'S FAILURE OR REFUSAL TO FOLLOW THE TERMS OF THIS AGREEMENT. IF YOU AND THE VILLAGE OF EDGAR CANNOT AGREE ON TERMS, YOU MAY ASK THE PUBLIC SERVICE COMMISSION 1-800-225-7729 TO REVIEW THE DISPUTED ISSUES.
